Additionally, during the new business segment, it was proposed that past presidents be honored at the next conventions, and this suggestion was unanimously agreed upon.

Lastly, Mr. Cooper recommended increasing the convention fees from \$90 to \$125. Other suggestions included \$100 and \$150. After thorough deliberations and a vote, 17 members concurred that the convention fees should be raised to \$100. The motion passed.

Next Venue for the 24th Annual Convention

Ms. Gertrude Freeman from the State of Minnesota volunteered to host the 2024 Annual Convention. Participants unanimously agreed and thanked Ms. Freeman for her willingness to host the 2024 Annual National Convention. The President ceremoniously appointed Ms. Gertrude G.
