In addition, Honorable Russell called on the participants to assist and support vulnerable Liberian communities and inspire others through our dedication and services. "We should not see vulnerable people as "victims" – they have so much to offer; we should embrace them as assets

and incorporate their talents and skills in our efforts." Furthermore, the Councilman admonished participants to search for "socially inclusive" avenues to allow and motivate people involvement and participation in achieving that goal. Honorable Russell thanked the Association for action taken to enhance its support of service to its people and encourage the Association to do more.

Greetings

Madam Vice President, Members of the Executive Committee, Colleagues, Ladies and Gentlemen.

With humility and reverence to the Almighty God, the Great Architect of the Universe, I greet you. It is an honor and privilege to appear before you and to bring you my **Stewardship Report on the State of our Association** for the past two years and the current period under review, August 10, 2019 - August 13, 2022. Due to the deadly COVID 19 pandemic, which wiped out many of our fellow citizens, we could not meet for the past two years. Thank God that we can meet in person this year.

Acknowledgement

Let me begin by praising and acknowledging the Great Architect of the Universe, through whose Grace and Mercy I am able to gather strength and announce myself among the living, and to appear before you today to tender in this brief account of my stewardship as the 8th President of Cape Palmas High School Alumni Association, USA, INC. We have come a mighty long way since our elections on August 18, 2018, to serve this August body. It has been a lot of hard work and sometimes bad feelings emerged during deliberation. However, the overall support and cooperation that we have received from the Executive Committee and the entire membership are extraordinary, and for this, I am grateful.

This report provides a synopsis of my stewardship as your President during the past year and the previous two years that we were unable to assemble due to the deadly pandemic. It also proffers our accomplishments during those three years. Furthermore, the report pays tributes to our stakeholders for the support and encouragement during our time of service to this Association. Additionally, we pay tribute to our fallen colleagues who have predeceased us, most especially Mr. Jenkin Cooper, who served this Association as our second President. Please join me in a minute of silence. May his and the souls of the faithful departed rest in perpetual peace.

Financial Standing

Colleagues, our Association is in good hands; our finances are well guarded; and the state of our Association is very strong and healthy as compared to when we first took over the leadership on August 18, 2018. Throughout the period under review, and during the COVID-19 pandemic years, several initiatives were implemented that generated revenues for the Association, including the hosting of the Global Connection Conference in December 2021. We also disbursed funds for the implementation of programs, including our first Professional Development Workshop for the faculty and staff of CPHS.

Taking a critical view of our financial positions, Tables I, II, III and IV in the Financial Secretary's Report, indicate the aggregate health of our Association. **Table I** illustrates the total amount of funds \$18,161.00 generated from Dues Payments, Water System Project Contributions, and the Global Connection Conference (GCC) Initiative. The Global Connection Conference was our highest fundraising initiative. **Table II** indicates the total cost of major projects that we have undertaken since our Administration was elected to lead the Association. In total we have disbursed \$9,465.75 on big projects, including the purchase of our 501(C) (3) Status, Website Design, and the Library Refurbishment Project. **Table III** shows our biggest fundraising event ever, the Global Connection Conference, which was held on December 11, 2021. This event generated \$5,625.00 in pledges. The GCC focused on three important development projects:

- 1. Science Laboratory upgrade generated \$2,275.00
- 2. Library upgrade received \$1,300.00
- 3. Teacher Training generated \$2,050.00

For details of payments and pledges still outstanding, please reference Table III. **Table IV** illustrates funds received from Online Direct and PayPal Payments through our website. To date, we received \$3,765.00 from Direct and PayPal Payments. We also incurred a total fee of \$122.51 from the payments received. Out Net after the fees amounts to \$3,642.49.

Colleagues, I want to sincerely thank you for your strong support to the Association, especially during the peak of the COVID-19 pandemic years. During the period between 2020 and 2021 Administrative Year, members paid their dues. In 2020, we received a total of \$1,960.00, while in 2021, members paid \$1,620.00 in dues to honor their commitment to the Association. This is

commendable and those members must be applauded for their efforts. Even in the wake of the pandemic when the world economy was under stressed, our members showed their due diligence. As you know, our major source of revenue generation is from due payments. As of July 15, 2022, the Association account balance stands at \$5,597.17. For detailed financial reports, please reference the Treasurer's and the Financial Secretary's Annual Reports. I want to thank the Financial Secretary and especially; the Treasurer for keeping excellent records of the Association's fiscal accounts, which echoed our Administration's pledge to be accountable and transparent to its membership.

Accomplishments

Colleagues, during the period under review and throughout the two other years of COVID19, the leadership of this Administration has completed many projects and other initiatives. What we have accomplished over the past three years, despite COVI19, is commendable and we are extremely proud and, at the same time, very humble. My sincerely gratitude to the Executive Committee for their support and cooperation in assisting me to deliver these little but important accomplishments.

Website Upgrade

The Association enhanced its **website** with many Pages added. We now have over 10 Pages and Links. The News Page provides regular updates from the President on the State of the Association. The Document Page contains over 15 pieces of documents, including reports such as the President Annual Reports, Annual Convention Reports, Project Reports, Professional Development Report, etc., etc. Since the upgrade of the website, I am pleased to inform you that we have seen over 50 visitors to the website in the past two years.

Let me remind you that there are several costs associated with building and maintaining the website. It will cost the Association \$264.00 to maintain the website through WIX.Com every two years and \$27.90 to keep the cphsaa-usa.org domain. It is, therefore, very essential that future leadership endeavors to keep the website updated and ensure that the maintenance and renewal fees are paid on time.

Currently, information on the website is imported by the Secretary with the advice of the President. Thanks to the. General Secretary, Mr. Homa Allison for his dedication to this project. Mr. Allison has done extremely well to keep the website functional. I am very grateful to have had him as Secretary for the past four years.

Online Payment

The Association has established an **Online Payment** mechanism for members, stakeholders, and friends of the Association. Our website can now accept online due payments and donations. As of June 30, 2022, our online Net earnings total is \$3,642.49. To make a payment or contribution, please go to **Cphsaa-usa.org** and click on membership. We encourage all CPHSAA-USA Alumni to sign in to make payments. Guests and other stakeholders can use the donation link on the Home Page or the Contact Page. Payments can be made via Credit and Debit Cards directly or through PayPal. We are very proud of this accomplishment.

Global Connection Conference

The Association had its very first major Global Connection Conference, which was held on Saturday, December 11, 2021. The Conference was held virtually by Zoom and started at 12: 00 EST Time/5:00 PM GMT (Liberian Time). The Theme of the Conference was "Globally Connecting To Help The Underprivileged: Extending A Helping Hand To Our Alma Mater; Our County; and Our Country." The Conference was blessed with the presence of Ms. Elene Saba, CEO of Teach For Liberia as our Keynote Specker. The Conference was also blessed with the presence of Ms. Anna Sleweon, Principal of CPHS and Mr. P. Mark, District Education Officer of Maryland County, as our Special Guests. Moreover, the Conference brought together CPHS Alumni Associations worldwide, including Liberia, CPHS' current staff and students, as well as key county officials.

During the Global Connection Conference, pledges were made to raise funds for projects and initiatives for the school. In total, we received \$5,625.00 in pledges. As of today's date, we received \$4,675.00 in payments and \$950.00 is outstanding. The donations are broken-down in three project areas of support:

1. Laboratory Upgrade

The Lab upgrade pledges raised \$2,275,00. The five members who pledged for this project have all honored their obligations.

2. Library Upgrade

The Library Upgrade pledges raised \$1,300.00. Of the four members who pledged, three members have honored their obligations, while one member is still obligated.

3. Teacher Training

The Teacher Training pledges raised **\$2,050.00**. Of the 11 members who pledged, seven members have honored their obligations, while four members are still obligated.

For detailed break-down, please see Table III of the Financial Secretary's Report.

Special thanks to those who attended, pledged, and paid their obligations to these projects. My gratitude to Mr. Abrom Cooper who chaired this Ad Hoc Committee and the DMV Group for planning, organizing, and implementing this milestone project.

Teachers Professional Development Workshop

The Association successfully implemented its very first Professional Development Workshop for the teachers and staff at CPHS. The Workshop was held in Harper, Maryland County by Dr. Blidi Stemn. There were over 25 participants. Please visit our website for the details of this splendid report at cphsaausa.org. My gratitude to Dr. Stemn for undertaking this initiative on behalf of the Association.

Water System Project

As you are aware, the Association is still undertaking the construction of a Water System Project. As mentioned previously, this project will solve decades long problem of students and support staff carrying water by buckets and containers into the school building to flush toilets, wash hands, and use in the Science lab.

However, there has been some problems with the project. First, the raining season has stopped the progress on the project due to heavy down pour of rain. The contractors could not continue the work while the hole is filled with water. Secondly, there is a huge rock that formed a bed in the locality of the well that the contractors are finding extremely difficult to get rid of or bypass. Engineers from the Tubman University are trying to lend a helping hand for the completion of this project. You will be updated regularly by the leadership on the progress of this project. We are working with our contacts and the principal to find solutions to these problems.

Our Appreciation

Colleagues, Ladies and Gentlemen. Our Administration is very grateful to its membership for the cooperation and support that we have enjoyed during the period that we have served this August body. I am particularly grateful to the Executive Committee for their guidance and leadership in assisting me with the stewardship of this Association. The collective efforts of each member of the EC have helped us to reach some goals and objectives.
